Date: 16th November, 2017, 4 pm
Venue: Lotte World Hotel, Seoul, Korea

The General Assembly will form part of the **25rd TAFISA World Congress** to be held from 15th to 19th November, 2017, at the same venue. The Congress theme is "Active World 2030 – Defining a New Horizon". 1. Election of the 2017 – 2021 TAFISA President and Board of Directors

2. Selection of the Host Country for the 27th TAFISA World Congress 2021

Please also give careful consideration to whether a city within your country could be the host for the 27th TAFISA World Congress in 2021.

Typically, TAFISA World Congresses attract over 400 attendees from TAFISA member organisations, national Olympic committees and other Sport for All related international associations, as well as significant media coverage.

We also take this opportunity to politely remind you that those National Members who have not paid both their 2016 and 2017 membership fees will not be entitled to vote at the coming elections.


The complete agenda of the General Assembly will be sent to you in due time, but three months before the General Assembly at the latest.
